OPERATION & **M**AINTENANCE

Paper towels are manually withdrawn through dispensing slot until towels are depleted. Unit will continue to feed properly when reloaded with a partial load in place. Refill dispenser by unlocking door and replacing towels for an empty or partially empty unit. Dispenser supply is replenished and waste container is emptied manually on cycles determined by maintenance needs. Locking full-face door over compartments prevents unauthorized access or removal.

INSTALLATION

Mount unit in wall recess with #10 self-threading screws (by others) through concealed mounting holes provided. For compliance with ICC/ANSI A-117.1-2003 and 2010 ADA Accessibility Standards install unit with centerline of towel dispenser slot 48" [1219] maximum Above Finish Floor (AFF) only if clear floor forward reach or side reach access is provided. Be advised that local codes may require mounting centerline of towel dispenser slot 40" [1016] max AFF (e.g. California UBC/Title 24). Note that top of Rough Wall Opening (RWO) is 3/4" [19] below top of unit. For general utility install unit with centerline of towel dispenser slot between 49" [1245] and 56" [1422] AFF.

Rough Wall Opening (RWO) required is 11-1/2" [292] W x 53-1/2" [1359] H x 4-1/4" [108] D minimum
