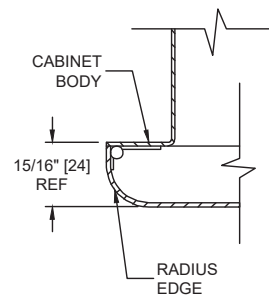
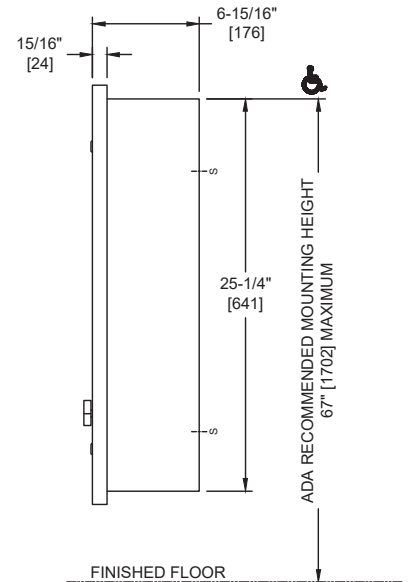
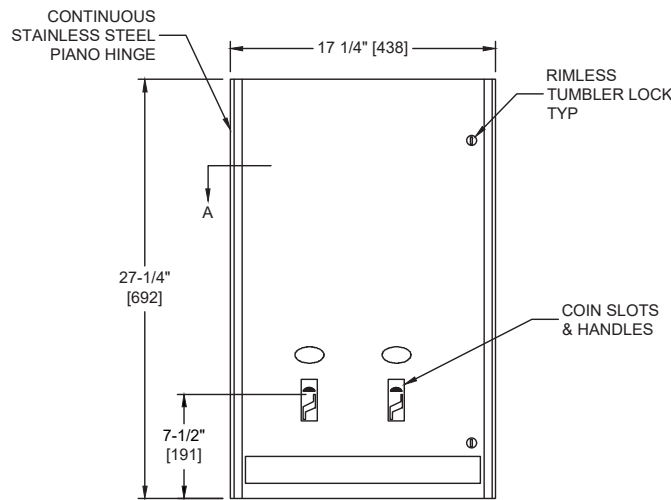

**PRODUCT OVERVIEW**

Dispenses 30 feminine napkins and 27 tampons. Door locked by two tumbler locks. Inside coin box has separately keyed lock. Universal coin mechanism allows for 25¢ and free (no coin) operation. Choose appropriate suffix (-25 or -F). Door shall be 16 gauge type 304 stainless steel alloy 18-8. Cabinet shall be 20 gauge same grade stainless steel. Door shall be attached with a multi-staked piano hinge and shall be held closed with two (2) rimless tumbler locks keyed alike to other ASI washroom equipment.

## OPERATION & MAINTENANCE

Deposit of specified coin allows operation of dispenser. Napkin and tampon dispensers operate independently. Selected product drops into vending opening after operator actuation. Indicator displays empty condition and blocks coin slot when product is depleted. Unit vend product supply is replenished on cycle determined by maintenance needs by opening door and manually reloading product into dispenser supply tracks. Locked compartment prevents unauthorized access. Track weights **MUST BE USED** to provide positive feed.

## INSTALLATION

Unit is mounted in wall recess using four (4) #10 self-threading screws (by others). For maximum usability and compliance with 2010 ADA Accessibility Standards, unit should be installed so that coin slot is between 54" [1372] maximum Above Finished Floor (AFF) and 38" [965] minimum AFF. Note that coin slot is 6-3/8" [162] above bottom edge of RWO.

Rough Wall Opening (RWO) required is 16" [406] W x 26" [660] H x 6-1/4" [159] D minimum
